The undersigned Guest (hereinafter referred to as "Guest") does hereby reserve the Banquet Room at Pilot Knob Park, Inc. (hereinafter referred to as "Club") for use on the _____ day of _____, 20____, during the hours of _____ for # _____ guests.

A two hundred dollar (\$200) deposit is required to reserve the Banquet Room. "Guest" acknowledges that he/she is responsible for the conduct of all persons using the aforesaid leased premises and is responsible for all damage to or sustained by "Club" property during or arising out of the use of the aforesaid facilities. "Guest" agrees to reimburse "Club" in full for such damage. "Guest" further agrees to leave the reserved premises clean and in good order following his use thereof. There will be a walkthrough of the facility to inspect its cleanliness by the "Club" Management following the function. Security guards will be on the premises for the duration of the party. A security guard for every 75 guests is required at an hourly rate of \$22 per hour (subject to change without notice).
